This is a summary of the annual report for the SHEET METAL WORKERS' HEALTH PLAN OF SOUTHERN CALIFORNIA, ARIZONA & NEVADA, Employer Identification Number 95-6052259, Plan Number 501, for the period January 1, 2005 to December 31, 2005. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has contracts with the following companies to pay medical and other insurance portion of the respective claims incurred under the terms of the Plan: Value RX Services for prescription drug benefits; United Concordia and Delta Dental for dental care benefits; Vision Service Plan for prepaid vision care, Kaiser Permanente, Pacificare, Health Plan of Nevada, Health Net and Hometown Health for medical claims.

The total premiums paid for the plan year ending December 31, 2005 were \$28,978,700.

**Basic Financial Statement**

The value of the plan assets, after subtracting liabilities of the plan, was \$51,173,190 as of December 31, 2005, compared to \$40,706,756 as of January 1, 2005. During the plan year, the plan experienced a change in its net assets of \$10,466,434. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$66,852,167 which included employer contributions of \$59,850,301, employee contributions of \$5,830,112, loss of \$225,340 from the sale of assets, unrealized gain from increase in value of investment of \$130,129, earnings from investments of \$1,170,453 and other income of \$96,512.

Total plan expenses were \$56,385,733. These expenses included \$3,537,549 in administrative expenses and \$52,848,184 in benefits paid to participants and beneficiaries.
